

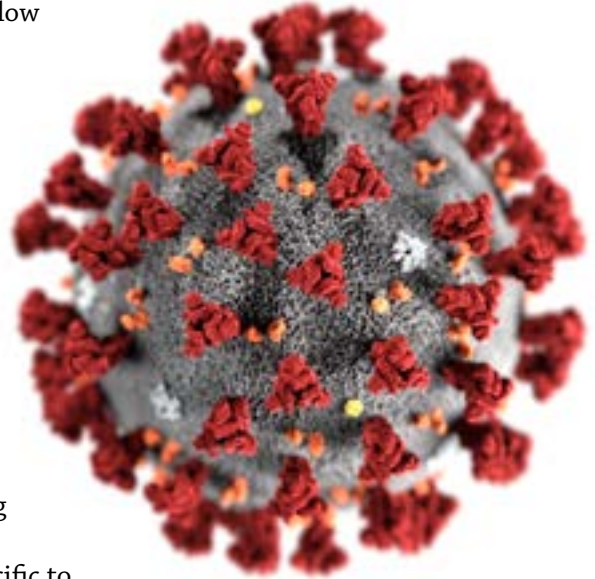
Suggestions for Youth Programs and Camps: Readiness and Planning Tool

CDC Readiness and Planning Tool to Prevent the Spread of COVID-19 Among Campers

CDC offers the following readiness and planning tool to share ways camp administrators can help protect campers, staff, and communities, and slow the spread of COVID-19. This tool aligns with the [Suggestions for Camps](#), and includes the following:

Camp and youth program administrators may review and complete the general readiness assessment while working with state, local, tribal, territorial, or federal officials when making initial preparations to promote healthy behaviors, environments, and operations that reduce the spread of COVID-19. The daily/weekly readiness assessment may be used to monitor and maintain recommended practices. Planning tools are also included to help camp and youth program administrators prepare for if someone gets sick and identify special considerations specific to their program and participants, as well as the unique needs and circumstances of the local community. Implementation should be guided by what is feasible, practical, acceptable and tailored to the needs and context of each community.



Guiding Principles to Keep in Mind

The more people a camper or staff member interacts with, and the longer that interaction, the higher the risk of COVID-19 spread. The risk of COVID-19 spread increases in youth camp settings as follows:

- **Lowest Risk:** Small groups of campers stay together all day, each day. Campers remain at least 6 feet apart and do not share objects. Outdoor activities are prioritized. All campers are from the local geographic area (e.g., city, town, county, community).
- **More Risk:** Campers mix between groups but remain at least 6 feet apart and do not share objects. Outdoor activities are prioritized. All campers are from the local geographic area (e.g., community, town, city, or county).
- **Even More Risk:** Campers mix between groups and do not remain spaced apart. All campers are from the local geographic area (e.g., community, town, city, or county).
- **Highest Risk:** Campers mix between groups and do not remain spaced apart. All campers are not from the local geographic area (e.g., community, town, city, or county).

<p>Point Person(s): _____</p> <p>Review relevant local/state regulatory agency policies and orders, such as those related to events, gatherings, and travel.</p> <p>Designate a staff person responsible for responding to COVID-19 concerns. Make sure other staff, parents, and campers know how to contact this person.</p> <p>Develop policies that encourage sick staff members to stay at home without fear of job loss or other consequences and protect their privacy, particularly for those with underlying medical conditions and at higher risk for severe illness.</p> <p>Offer options for staff and campers at higher risk for severe illness (e.g., telework or virtual learning opportunities).</p> <p>Offer flexible sick leave policies and practices.</p> <p>Offer options for flexible worksites (e.g., telework) and flexible work hours (e.g., staggered shifts).</p> <p>Develop a plan to monitor absenteeism of campers and staff, cross-train staff, and create a roster of trained back-up staff.</p> <p>Develop a plan to conduct daily health checks (e.g., temperature screening and/or symptom checking) of staff and campers, as possible, and in accordance with any applicable privacy laws and regulations.</p> <p>Develop a plan for campers to stay in small groups with dedicated staff and remain with the same group throughout the day, every day.</p> <p>Develop a plan for campers to bring their own meals or for serving individually plated meals, if possible. Consider staggering mealtimes or having campers eat in separate areas or with their small group instead of in a communal space.</p> <p>Develop protocols to limit contact between small groups and with other campers' guardians (e.g., staggered arrival and drop-off times or locations).</p> <p>Develop a plan for if someone gets sick or shows symptoms of COVID-19.</p> <p>Other: _____</p>	<p>Point Person(s): _____</p> <p>Obtain supplies including:</p> <ul style="list-style-type: none"> soap hand sanitizer (at least 60% alcohol) paper towels tissues cleaning and disinfection supplies cloth face coverings (as feasible) no-touch/foot pedal trash cans no-touch soap/hand sanitizer dispensers disposable food service items other: _____ <p>Develop a schedule for increased routine cleaning and disinfection in collaboration with maintenance staff, including areas such as the following:</p> <ul style="list-style-type: none"> buses or other transport vehicles frequently touched surfaces (e.g., desks, door handles, railings) communal spaces (e.g., restrooms) shared objects (e.g., gym equipment, art supplies, games) other: _____ <p>Close shared spaces; otherwise develop a plan for staggered use and cleaning and disinfecting.</p> <p>Develop a plan for regular cleaning and disinfecting of buses or other transport vehicles, see guidance for bus transit administrators.</p> <p>Develop protocol to ensure safe and correct use and storage of cleaners and disinfectants; including storing products away from children.</p> <p>Ensure ventilation systems operate properly. If using fans, make sure they do not blow from one person onto another.</p> <p>Ensure all water systems and features are safe to use after a prolonged facility shutdown.</p> <p>Follow CDC's considerations for Pools, Hot Tubs, and Water Playgrounds During COVID-19.</p> <p>Install physical barriers, such as sneeze guards and partitions, in areas where it is difficult for individuals to remain at least 6 feet apart.</p> <p>Provide physical guides, such as tape on floors and signs on walls, to promote social distancing.</p> <p>Space seating at least 6 feet apart.</p> <p>Develop protocol to increase circulation of outdoor air as much as possible (e.g., opening windows and doors when it is safe to do so).</p> <p>Develop protocol to monitor and ensure adequate supplies to minimize sharing of materials, or limit use to one group of campers at a time, and clean and disinfect between use.</p> <p>Encourage organizations that share the camp facilities to follow these considerations.</p> <p>Other: _____</p>	<p>Point Person(s): _____</p> <p>Educate staff, campers, and their families about when they should stay home if they become sick with COVID-19 symptoms, test positive for COVID-19, or have been exposed to someone with symptoms or a confirmed or suspected case, and when they can return to camp.</p> <p>Educate staff on flexible work and leave policies that encourage sick staff members to stay at home without fear of job loss or other consequences.</p> <p>Make plans for teaching the importance of handwashing with soap and water for at least 20 seconds.</p> <p>Make plans for teaching the importance of social distancing and staying with small groups, if applicable.</p> <p>Identify who should wear cloth face coverings, and communicate the importance of wearing them. Cloth face coverings should not be placed on:</p> <ul style="list-style-type: none"> • Children younger than 2 years old • Anyone who has trouble breathing or is unconscious • Anyone who is incapacitated or otherwise unable to remove the cover without help. <p>Provide information on proper use, removal, and washing of cloth face coverings.</p> <p>Train staff on all safety protocols.</p> <ul style="list-style-type: none"> • Conduct training virtually or maintain social distancing during training. <p>Other: _____</p>

<p>Point Person(s): _____</p> <p>Maintain regular contact with local health authorities to and review relevant local/state regulatory agency policies and orders for updates.</p> <p>Ensure a staff person (e.g., camp nurse or healthcare provider) is responsible for responding to COVID-19 concerns is assigned.</p> <p>Monitor absenteeism of campers and staff.</p> <p>Ensure roster of trained back-up staff is updated.</p> <p>Conduct daily health checks (e.g., temperature screening and/or symptom checking) of staff and campers, as possible, and in accordance with any applicable privacy laws and regulations.</p> <p>Ensure options for flexible worksites (e.g., telework) and flexible work hours (e.g., staggered shifts) are available and used when needed.</p> <p>Ensure campers are kept together in small groups with dedicated staff and remain with the same group throughout the day, every day.</p> <p>Adhere to and review protocols to limit contact between small groups and with other campers' guardians.</p> <p>Ensure small groups maintain a physical distance of at least 6 feet to avoid mixing between groups, if possible.</p> <p>Ensure campers eat in separate areas or with their small group.</p> <p>Ensure each camper's belongings are separated from others' and in individually labeled containers, cubbies, or designated areas.</p> <p>Ensure limited sharing of electronic devices, toys, books, and other games or learning aids, and clean and disinfect after each use.</p> <p>During naptime, assign mats to individual children, sanitize mats before and after use, and space them out as much as possible.</p> <ul style="list-style-type: none"> • Position campers head-to-toe to ensure distance between their faces. <p>Other: _____</p>	<p>Point Person(s): _____</p> <p>Monitor and restock supplies including:</p> <ul style="list-style-type: none"> soap hand sanitizer (at least 60 % alcohol) paper towels tissues cleaning and disinfection supplies cloth face coverings (as feasible) no-touch/foot pedal trash cans no-touch soap/hand sanitizer dispensers disposable food service items other: _____ <p>Monitor adherence to the schedule for increased, routine cleaning and disinfection of:</p> <ul style="list-style-type: none"> buses or other transport vehicles frequently touched surfaces communal spaces shared objects other: _____ <p>Monitor availability and use of gloves when removing garbage bags or handling and disposing of trash.</p> <p>Monitor safe and correct use and storage of cleaners and disinfectants, including storing products securely away from children.</p> <p>Ensure that there is adequate ventilation when cleaners and disinfectant are used to prevent children or staff from inhaling toxic fumes.</p> <p>Ensure ventilation systems operate properly.</p> <p>Ensure seating is spaced at least 6 feet apart.</p> <p>In transport vehicles, ensure one child per row, skipping rows when possible.</p> <p>For communal spaces, ensure staggered use, and cleaning and disinfecting frequently touched surfaces and shared objects between users.</p> <p>Increase circulation of outdoor air as much as possible (e.g., opening windows and doors when it is safe to do so).</p> <p>Ensure adequate supplies to minimize sharing of high-touch materials, and monitor cleaning and disinfecting between use.</p> <p>Other: _____</p>	<p>Point Person(s): _____</p> <p>Educate staff, campers, and their families about when they should stay home if they become sick with COVID-19 symptoms, test positive for COVID-19, or have been exposed to someone with symptoms or a confirmed or suspected case, and when they can return to camp.</p> <p>Educate staff on flexible work and leave policies that encourage sick staff members to stay at home without fear of job loss or other consequences.</p> <p>Reinforce and monitor handwashing with soap and water for at least 20 seconds.</p> <p>Encourage covering coughs and sneezes with a tissue, and then washing hands with soap and water for at least 20 seconds.</p> <p>Encourage social distancing and staying with small groups, if applicable.</p> <p>Reinforce the use of cloth face coverings. Suggestions for Youth Programs and Camps: Preparing for if Someone Gets Sick

Use the following tool when making initial preparations for if someone gets sick with COVID-19.

<p>Point Person(s): _____</p> <p>Make sure staff and families know they should not come to camp, and that they should notify camp officials if they become sick with COVID-19 symptoms, test positive for COVID-19, or have been exposed to someone with symptoms or a confirmed or suspected case.</p> <p>Develop systems to:</p> <ul style="list-style-type: none"> Have individuals self-report to the administrators if they have symptoms of COVID-19, a positive test for COVID-19, or were exposed to someone with COVID-19 within the last 14 days. Notify individuals of closures and restrictions put in place to limit COVID-19 exposure. Develop policies for returning to camp after COVID-19 illness. CDC's criteria to discontinue home isolation and quarantine can inform these policies. Identify an isolation room or area to separate anyone who has COVID-19 symptoms or who has tested positive but does not have symptoms. If a person becomes sick and needs to be transported, establish procedures to ensure safe transporting. Develop a plan to support staff, students, and families experiencing trauma or challenges related to COVID-19. <p>Other: _____</p>	<p>Point Person(s): _____</p> <p>Immediately separate individuals with COVID-19 symptoms.</p> <p>Care for sick individuals following CDC guidance for caring for yourself or others who are sick.</p> <p>If necessary, transport sick individual(s) to a healthcare facility, depending on how severe their symptoms are.</p> <p>If calling an ambulance or bringing someone to the hospital, try to call first to alert them that the person may have COVID-19.</p> <p>Close off areas used by a sick person and do not use these areas until after cleaning and disinfecting them (for outdoor areas, this includes surfaces or shared objects in the area, if applicable).</p> <p>Other: _____</p>	<p>Point Person(s): _____</p> <p>In accordance with state and local laws and regulations, notify local health officials, staff, and families of cases of COVID-19 while maintaining confidentiality in accordance with the Americans with Disabilities Act (ADA).</p> <p>Notify individuals of closures and restrictions put in place due to COVID-19 exposure.</p> <p>Advise those who have had close contact with a person diagnosed with COVID-19 to stay home, self-monitor for symptoms, and follow CDC guidance if symptoms develop.</p> <p>Wait at least 24 hours before cleaning and disinfecting. If 24 hours is not feasible, wait as long as possible. Ensure safe and correct use and storage of cleaning and disinfection products, including storing them securely away from children.</p> <p>Other: _____</p>
